

## FORENSIC ROYALTY DISCREPANCY REPORT

CERTIFIED DISCREPANCY  
ACTION REQUIRED

This report constitutes a Certified Forensic Audit regarding non-identified digital performance royalties associated with the sound recording listed herein. Forensic probing of the International Standard Recording Code (ISRC) registry has identified a significant gap between historical stream volume and current claimant registration.

### Stream-to-Statutory Calculation

Using CRB statutory rates:

**Conservative (\$0.0015/stream):** \$180,000.00

**Optimized (\$0.0031/stream):** \$372,000.00

### Methodology

Stream counts were aggregated from publicly available DSP data and ISRC lookups via MusicBrainz and IFPI registries. SoundExchange claimant status was verified against the public registry. The conservative estimate uses the SoundExchange Featured Artist statutory rate of \$0.0015 per stream; the optimized estimate uses \$0.0031 reflecting potential multi-platform and non-interactive broadcast inclusion.

### **3. REGULATORY STANDING & STATUTORY BASIS**

#### **3.1 Music Modernization Act (MMA)**

Under 17 U.S.C. S.114, SoundExchange is required to hold unmatched digital performance royalties in Suspense accounts. Performers who do not appear in SoundExchange's registry as claimants will have royalties held indefinitely until a valid Letter of Direction (LOD) and Repertoire Schedule are filed. The three-year lookback window means that accruals dating up to 36 months prior to filing are recoverable.

#### **3.2 AMP Act Compliance**

For legacy assets recorded prior to February 15, 1972, this audit complies with the Allocation for Music Producers (AMP) Act, which provides a statutory right for non-featured artists and producers to receive a portion of SoundExchange digital performance royalties. The AMP Act establishes a right of recovery separate from the featured artist LOD process.

#### **3.3 Black Box Royalty Recovery Framework**

Royalties classified as 'Black Box' or 'Suspense' at SoundExchange are recoverable via submission of:

- (1) LOD Part 1 - Letter of Direction from the artist or authorized representative;
- (2) Schedule 1 - Repertoire Chart listing ISRC codes and ownership data;
- (3) Evidence of Discrepancy - this forensic screening report serves as the required supporting documentation.

#### **LEGAL OPINION:**

Asset classified as "Unclaimed Black Box." Filing LOD Part 1 + Schedule 1 with SoundExchange (accounts@soundexchange.com) is the prescribed recovery method under 17 U.S.C. S.114. This report constitutes the Evidence of Discrepancy required for filing. Expected processing timeline: 30-90 days.
